DECISION n° 364

of the Management Board of the European Union Agency for Railways amending the budget 2024 (amendment n°1)

THE MANAGEMENT BOARD OF THE EUROPEAN UNION AGENCY FOR RAILWAYS,

Having regard to:

Regulation (EU) N° 2016/796 of the European Parliament and of the Council of 11 May 2016 on the European Union Agency for Railways¹ (hereinafter referred to as "the Agency") and repealing Regulation (EC) No 881/2004 (hereinafter called "the Regulation"), and in particular Articles 51 (1) point (c) and 64 (2) and (9) thereof;

Decision n°206 of the Management Board adopting the new ERA Financial Regulation, and in particular Article 34 of its Annex;

Decision n° 335 of the Management Board of the European Union Agency for Railways adopting the budget and establishment plan 2024;

Whereas:

- (1) The note of DG Budget on "Addressing the impact of higher forecasts for the salary adjustments on salary related expenditure in Budget 2024 and Draft Budget 2025 under headings 1 to 6" (Ares(2024)6583102 of the 18/09/2024) proposes a draft amending budget 2024 for an amount corresponding to 1.7% of their 2024 salary expenditures, multiplied by the share of the EU budget subsidy in the total budget of the Agency.
- (2) For the part of the budget corresponding to the fees and charges, the constant monitoring and forecast for the remaining period until the end of year did not point to any evolution beyond +/-10% compared to the initial budget adopted via Decision n° 335 of the Management Board.

HAS DECIDED AS FOLLOWS:

Article 1

The Annex to the MB decision n°335 is amended with the changes listed in the amending budget 2024 n.1 set out in Annex 1 to this decision.

Article 2

The amending budget 2024 is adopted subject to the adoption of the EU amending budget 2024 by the European Parliament and the Council of the European Union.

Article 3

The financial data pertaining to 2024 contained in the Agency's Single Programming Document 2024, Single Programming Document 2025, and budget decision 2025 will be read as amended with the changes brought by this decision.

Article 4

This decision shall enter into force on the day of the adoption of the EU amending budget 2024 by the Budgetary Authority, i.e. the European Parliament and the Council of the European Union.

It will be published on the Agency website together with the consolidated budget 2024 resulting after the changes listed in Annex 1.
