

DECISION n° 118

of the Administrative Board of the European Railway Agency adopting an amendment to the Work Programme 2015

THE ADMINISTRATIVE BOARD OF THE EUROPEAN RAILWAY AGENCY,

Having regard to Regulation (EC) No 881/2004 of the European Parliament and of the Council¹ establishing a European Railway Agency (hereinafter referred to as "the Agency"), and in particular article 25 (2) c thereof.

Having regard to the ERA Work Programme 2015 adopted by the Administrative Board on 26 November 2014,

Having regard to the ERA Financial Regulation and in particular Article 32 (4) thereof,

Having regard to Commission Delegated Regulation (EC) n°1268/2012 on the Rules of Application of Regulation n° 966/2012 and in particular Articles 94(3) and 94 (4) thereof,

Whereas:

- 1. A number of activities in view of the preparation for the new legislative framework of the Agency and the procurement plan will have to be modified and updated to reflect the changes in the work and the needs of the Agency.
- 2. The changes are substantial enough to justify an amendment to the annual work programme which will have to be adopted by the same procedure as the initial work programme.

HAS DECIDED AS FOLLOWS:

Article 1

The projects in Activities 1, 2, 4 and 5, related to Common Occurrence reporting, NIB interaction, Rules Strategy, preparation for the 4RWP and the development of Registers shall be added and/or updated as per Annex I to this decision.

Article 2

Annex II to the Agency's Work Programme 2015 shall be replaced by the Annex II to this decision.



Article 3

This decision shall enter into force on the day following that of its adoption. It will be published on the Agency website.
