Code	Registration status	Registration status reason	Description
00	Valid	Not applicable	The vehicle has a valid registration.
01	Valid	Valid registration with limited ECM capability	The vehicle has a valid registration, the maintenance capability is certified in the scope of the SSC assessment.
10	Suspended	Not applicable	Kept for historical reasons, not to be used anymore (Historical reasons: The vehicle's registration is suspended at the request of the keeper or by a decision of the NSA of the registering Member State or VRE)
11	Suspended	Storage in working order as an inactive or strategic reserve	The vehicle registration is suspended upon request of the vehicle keeper as the vehicle is destined for storage in working order as an inactive or strategic reserve.
12	Suspended	Information to be specified by the vehicle keeper.	The vehicle registration is suspended upon request of the vehicle keeper for other reason to be specified.
13	Suspended	Information to be specified by the NSA of the Member State where it is registered or the Agency	The vehicle registration is suspended at the request of the NSA of the Member State where it is registered or the Agency for a reason to be specified
14	Suspended	Information to be specified by the RE	The vehicle registration is suspended by decision of the VRE for a reason to be specified.
15	Suspended	Expired ECM certificate	The vehicle registration is suspended by decision of the VRE or by the Agency upon notification of the EVR IT system
20	Withdrawn	Not applicable	Kept for historical reasons, not to be used anymore (Historical reasons: The vehicle registration is withdrawn at the request of the keeper. The vehicle is known to be re-registered under a different number, for continued use on (all or part of the) Union rail system)

21	Withdrawn	Vehicle re-registered under a different EVN due to technical modifications	The vehicle registration is withdrawn at the request of the vehicle keeper. The vehicle is known to be re-registered under a different EVN due to technical modifications of the vehicle.
22	Withdrawn	Vehicle re-registered under a different EVN with a different place of registration part of it	The vehicle registration is withdrawn at the request of the vehicle keeper. The vehicle is known to be re-registered under a different EVN with a different place of registration part of it
30	Withdrawn	To be specified by the vehicle keeper	The vehicle registration is withdrawn at the request of the vehicle keeper. The vehicle registration for operating on the Union rail system has expired without known re-registration.
31	Withdrawn	Continued use outside the Union rail system	The vehicle registration is withdrawn at the request of the vehicle keeper. The vehicle is destined for continued use as a rail vehicle outside the Union rail system.
32	Withdrawn	Destined for the recovery and reuse materials	The vehicle registration is withdrawn at the request of the vehicle keeper. The vehicle is destined for the recovery and reuse materials (interoperability constituents, modules, spares parts)
33	Withdrawn	Scrapped and disposed waste recycling of materials	The vehicle registration is withdrawn at the request of the vehicle keeper. The vehicle has been scrapped and disposed for waste recycling of materials

34	Withdrawn	Historic preserved rolling stock	<p>The vehicle registration is withdrawn at the request of the vehicle keeper.</p> <p>The vehicle is destined to be 'historic preserved rolling stock' for operation on a segregated network, or for static display, outside the Union rail system.</p>
