## DATA PROTECTION NOTICE

## 4<sup>TH</sup> ERA ENISA CONFERENCE: CYBERSECURITY IN RAILWAYS

The "4<sup>th</sup> ERA-ENISA Conference: Cybersecurity in Railways" is co-organised by the European Union Agency for Cybersecurity (ENISA) and the European Union Agency for Railways (ERA). The event will take place in a physical format on the 2th and 3th October 2024.

**Your personal data** in the context of the 4<sup>th</sup> ERA-ENISA Conference shall be processed in accordance with the Regulation (EU) 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data<sup>1</sup>.

**The joint data controllers** of the processing operation are **ENISA** (Policy Development and Implementation Unit) and **ERA** (Railway System Department) who are responsible for the overall organisation of the conference (including registration of participants), the communication with the participants before and after the end of the event and the collection of feedback.

**The legal basis** for the processing operation for ENISA is article 5(1)(a) of Regulation (EU) 2018/1725, on the basis of Regulation (EU) No 881/2019, in particular the provisions establishing the tasks of ENISA.

**The legal basis** for the processing operation for ERA is article 5(1)(a) of Regulation (EU) 2018/1725, on the basis of Regulation (EU) No 2016/796 in particular the provisions establishing the tasks of ERA.

**The purpose** of this processing operation is to facilitate the organisation of the event, register interested persons to the 4<sup>th</sup> ERA-ENISA Conference, include them in the participants list; provide access to the workshop venue; allow the follow up of the event, including feedback collection and specific communication activities.

**The data processor** of the processing operation is European Commission EU Survey tool<sup>2</sup>, which is used for expression of interest to participate to the event.

## The following personal data are processed for the events' participants:

- Contact data: first name, last name, organisation, affiliation, e-mail address.
- Optional data: Role/position within the organisation, country.
- Other data Any comments from people registering for the event.

**The retention periods** for the personal data are as follows: **The final participants list** (name, surname, organisation) will be kept for a maximum period of 5 years after the end of the event for auditing purposes. **Your contact data** will be kept for a maximum period of six months after the end of the event for communication/follow-up of the event.

**Access to your data** is granted only to ENISA and ERA staff involved in the organisation of the 4<sup>th</sup> ERA-ENISA Conference, and bodies charged with monitoring or inspection tasks in application of EU law (e.g. internal audits, European Anti-fraud Office – OLAF).

You have the right of access to your personal data and to relevant information concerning how we use it. You have the right to rectify your personal data. Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time. We will consider your request, take a decision and communicate it to you.
