DECISION n° 356

of the Management Board of the European Union Agency for Railways amending the Single Programming Document 2024-2026 (#3)

THE MANAGEMENT BOARD OF THE EUROPEAN UNION AGENCY FOR RAILWAYS,

Having regard to Regulation (EU) N $^{\circ}$ 2016/796 of the European Parliament and the Council of 11 May 2016 on the European Union Agency for Railways (hereinafter referred to as "the Agency") and repealing Regulation (EC) No 881/2004 (hereinafter called "the Regulation"), and in particular Article 51§1 (b) and 52§4 thereof,

Having regard to Decision n°336 of the Management Board adopting the Single Programming Document 2024,

Having regard to Decision n°206 of the Management Board adopting the new ERA Financial Regulation,

Having regard to Decision n°317 of the Management Board on delegating powers to the Executive Director to adopt non-substantial amendments to the Single Programming Document and repealing Decision n°289,

Having regard to Decision n°206 of the Management Board adopting the new ERA Financial Regulation,

Having regard to Decision n°342 of the Management Board amending the Single Programming Document 2024-2026 (#1),

Having regard to Decision n°353 of the Management Board amending the Single Programming Document 2024-2026 (#2).

HAS DECIDED AS FOLLOWS:

Article 1

The Agency's Single Programming Document 2024 is amended with the substantial changes listed in the Annex.

Rationale of the requested change:

The FWC was omitted in the previous SPDs due to an administrative oversight during the drafting. Once the omission was discovered, the errors was reported in the Nonconformity register of the Agency and this amendment is part of the corrective measures taken to rectify the situation as the FWC is still valid until the end of the year. The omission of the FWC from previous SPDs (starting with SPD 2017) did not result in any misuse or misallocation of resources. The Agency's strategic priorities and objectives remained aligned with the intended scope of this framework contract. Furthermore, all operational and financial decisions of the previous years were compliant with the minimum legal requirements: Art.72.3 of the ERA Financial Regulation stipulates that the Financiang Decision (i.e., SPD) shall also set out for procurement: the global budgetary envelope reserved for procurements. However, in order to foster financial accountability and operational transparency, the Agency is publishing additional information regarding the use of the FWC which was not reflected in the past SPDs with respect to this FWC.
